## Invitation to Bid for

### **CONCRETING OF BRGY. #04 POBALACIONB FARM-TO-MARKET ROAD (Follante section and Manzano section)**


1. The **LGU - PASUQUIN** through the **SURPLUS CY 2020** intends to apply the sum of **Php 799,992.74** being the Approved Budget for the Contract (ABC) to payments under the contract for **MGPIN – 2021 – 02 – 025 Concreting of Brgy. #04 Poblacion Farm to Market Road, located at Barangay #04 Poblacion, Pasuquin, Ilocos Norte.** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LGU - PASUQUIN** now invites bids for Improvement of **Concreting of Brgy. #04 Poblacion Farm to Market Road (Follante Section and Manzano Section), located at Brgy. #04 Poblacion, Pasuquin, Ilocos Norte.** Completion of the Works is required **twenty five (25) calendar days.** Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **LGU – PASUQUIN** and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **February 10 – March 03, 2021** from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 1,000.00.*
6. The **LGU - PASUQUIN** will hold a Pre-Bid Conference on **February 19, 2021 at 1:00 PM** at **BAC Office, 2<sup>nd</sup> Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte** which shall be open to prospective bidders.

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.

9. Bid opening shall be on **March 03, 2021 2:00 PM** at *BAC Office, 2<sup>nd</sup> Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
