

Invitation to Bid for

CONCRETING OF DAVILA FARM-TOMARKET ROAD (Aguis Section)

- The LGU PASUQUIN through the SURPLUS CY 2020 intends to apply the sum of Php 499,938.02 being the Approved Budget for the Contract (ABC) to payments under the contract for MGPIN 2021 02 024 Concreting of Davila fram to Market Road (Aguis Section), located at Barangay #05 Davila, Pasuquin, Ilocos Norte. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU PASUQUIN now invites bids for Improvement of Concreting of Davila Farm to Market Road (Aguis Section), located at Brgy. #05 Davila, Pasuquin, Ilocos Norte. Completion of the Works is required fifteen (15) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from LGU PASUQUIN and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on September 23 October 01, 2021 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 1,000.00.
- 6. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before *October 01*, 2021 at 1:30 PM. Late bids shall not be accepted. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.

Bid opening shall be on October 01, 2021 2:00 PM at BAC Office, 2nd Floor, Municipal Sports Complex, Pasuguin, Ilocos Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
