
Invitation to Bid for

CONCRETING OF PANGIL FARM TO MARKET ROAD ***(Proper Road Section)***

1. The *LGU - PASUQUIN* through the *CY 2018 – RA 8240* intends to apply the sum of *Php 1,147,709.80* being the Approved Budget for the Contract (ABC) to payments under the contract for *MGPIN – 2022 –01 - 027 – Concreting of Pangil Farm to Market Road (Proper Road Section)* located at *Barangay #15 Pangil, Pasuquin, Ilocos Norte*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *LGU - PASUQUIN* now invites bids for *Concreting of Pangil Farm to Market Road (Proper Road Section)* located at *Barangay #15 Pangil Pasuquin, Ilocos Norte*. Completion of the Works is required *twenty eight (28) calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *LGU – PASUQUIN* and inspect the Bidding Documents at the address given below from *8:00 AM to 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested bidders on , *December 09 - 29, 2021* from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Php 5,000.00*.
6. The *LGU - PASUQUIN* will hold a Pre-Bid Conference¹ on *December 17, 2021 at 1:00 PM* at *BAC Office, 2nd Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte* which shall be open to prospective bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before *December 29, 2021 at 1:30 PM*. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
9. Bid opening shall be on *December 29, 2021 2:00 PM* at *BAC Office, 2nd Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

11. The *LGU - PASUQUIN* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 41 of RA No. 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
