## Invitation to Bid for

### **REPAIR OF LIGHTINGH SYSTEM (PUBLIC PLAZA)**

1. The *LGU - PASUQUIN* through the *MOOE (Repair and Maintenance – Historical Site)* intends to apply the sum of **Php 499,992.94** being the Approved Budget for the Contract (ABC) to payments under the contract for *MGPIN – 2022 –11 - 185 – Repair of Lighting System (Public Plaza)* located at *Barangay #01 Poblacion Pasuquin, Ilocos Norte*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *LGU - PASUQUIN* now invites bids for *Repair of Lighting System* located at *Barangay #01 Polacion, Pasuquin, Ilocos Norte*. Completion of the Works is required *twenty-eight (28) calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *LGU – PASUQUIN* and inspect the Bidding Documents at the address given below from *8:00 AM to 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *November 22 – December 01, 2022* from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 500.00*.
6. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before *December 01, 2022 at 1:30 PM*. Late bids shall not be accepted.
7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.

8. Bid opening shall be on **December 01, 2022 2:00 PM** at *3rd Floor, Municipal Hall, Pasuquin, Ilocos Norte*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
