

Invitation to Bid for

CONCRETING OF SAN JUAN FARM TO MARKET ROAD (DALERE SECTION)

- The LGU PASUQUIN through the RA 7171 CY 2019 intends to apply the sum of Php 808,983.92 being the Approved Budget for the Contract (ABC) to payments under the contract for MGPIN 2022 -11 155 Concreting of San juan Farm to Market Road (Dalere Section) located at Barangay #29 San Juan, Pasuquin, Ilocos Norte. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The LGU PASUQUIN now invites bids for Concreting of San juan Farm to Market Road (Dalere Section) located at Barangay #29 San Juan, Pasuquin, Ilocos Norte. Completion of the Works is required sixteen (16) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *LGU PASUQUIN* and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *November 11 December 13, 2022* from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 1,000.00.
- 6. The *LGU PASUQUIN* will hold a Pre-Bid Conference¹ on *December 01, 2022* at 1:00 PM at 3rd Floor, Municipal Session Hall, Pasuquin, Ilocos Norte which shall be open to prospective bidders.

May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before *December 13, 2022 at 1:30 PM*. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on *December 13, 2022 2:00 PM* at 3rd Floor, Municipal Hall, Pasuquin, Ilocos Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. Municipality of Pasuquin with address Maharlika Highway, Barangay 01 Poblacion, Ilocos norte with contact number (077) 677-1128.
- 11. The *LGU PASUQUIN* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 41 of RA No. 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
