





Invitation to Bid for

CONCRETING OF SAN JUAN FARM TO MARKET ROAD (Maumel Section)

1. The *LGU - PASUQUIN* through the **EDF CY 2023** intends to apply the sum of **Php 2,199,971.55** being the Approved Budget for the Contract (ABC) to payments under the contract for **MGPIN – 2023 –01 - 003 – MGPIN – 2023 –01 - 003 – Concreting of San Juan Farm to Market Road (Maumel Section)** located at **Barangay #29 San Juan, Pasuquin, Ilocos Norte**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *LGU – PASUQUIN* now invites bids for the **Concreting of San Juan Farm to Market Road (Maumel Section)**, located at **Barangay #29 San Juan, Pasuquin, Ilocos Norte**. Completion of the Works is required **nineteen (19) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *LGU – PASUQUIN* and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **February 07 - 27, 2023** from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
6. The *LGU - PASUQUIN* will hold a Pre-Bid Conference¹ on **February 15, 2023 at 1:00 PM** at **BAC Office, 2nd Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte** which shall be open to prospective bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **February 27, 2023 at 1:30 PM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **February 27, 2023 2:00 PM** at *BAC Office, 2nd Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **LGU - PASUQUIN** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
