CEILING AND ELECTRICAL - AGRITECH BUILDING (Phase II)

- The LGU PASUQUIN through the LOCAL SCHOOL BOARD FUND FY 2022-CONTINUING intends to apply the sum of Php 540,120.00 being the Approved Budget for the Contract (ABC) to payments under the contract for MGPIN 2023 05 062 CEILING AND ELECTRICAL AGRITECH BUILDING (Phase II) located at Ilocos Norte Agricultural College (INAC), Barangay #18 San Isidro, Pasuquin, Ilocos Norte. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The LGU PASUQUIN now invites bids for MGPIN 2023 05 062 CEILING AND ELECTRICAL AGRITECH BUILDING (Phase II) located at llocos Norte Agricultural College (INAC), Barangay #18 San Isidro, Pasuquin, llocos Norte. Completion of the Works is required twenty-three (23) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from **LGU PASUQUIN** and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on, May 10 30, 2023 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 1,000.00.
- 6. The **LGU PASUQUIN** will hold a Pre-Bid Conference¹ on **May 18, 2023** at **1:00 PM** at 3rd Floor, Municipal Hall, Pasuquin, Ilocos Norte which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before *May* 30, 2023 at 1:30 PM. Late bids shall not be accepted.

May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on **May 30, 2023, 2:00 PM** at 3rd Floor, Municipal Hall, Pasuquin, Ilocos Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
