COMPLETION OF SCHOOL COVERED COURT

- The LGU PASUQUIN through the LOCAL SCHOOL BOARD FUND FY 2022-CONTINUING intends to apply the sum of Php 479,888.06 being the Approved Budget for the Contract (ABC) to payments under the contract for MGPIN - 2023 - 05 - 063 - COMPLETION OF SCHOOL COVERED COURT located at Davila National High School, Barangay #05 Davila, Pasuquin, Ilocos Norte. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU PASUQUIN now invites bids for MGPIN 2023 05 063 COMPLETION OF SCHOOL COVERED COURT located at Davila National High School, Barangay #05 Davila, Pasuquin, Ilocos Norte. Completion of the Works is required twenty-four (24) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from **LGU PASUQUIN** and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on, May 10 30, 2023 from given address and website/s below and upon payment of the applicable-fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 500.00.
- 6. The **LGU PASUQUIN** will hold a Pre-Bid Conference¹ on **May 18, 2023** at **1:00 PM** at 3rd Floor, Municipal Hall, Pasuquin, Ilocos Norte which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **May** 30, 2023 at 1:30 PM. Late bids shall not be accepted.

May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on **May 30, 2023, 2:00 PM** at 3rd Floor, Municipal Hall, Pasuquin, llocos Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
