CONCRETING OF BRGY. #04 POBLACION FARM TO MARKET (Marabrabaw – Lussok Section)

1. The **LGU - PASUQUIN** through the **EDF CY 2023** intends to apply the sum of **Php 294,957.40** being the Approved Budget for the Contract (ABC) to payments under the contract for **MGPIN – 2023 –03 - 037 – Concreting of Brgy. #04 Poblacion farm To Market Road** located at **Barangay #04 Poblacion, Pasuquin, Ilocos Norte**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LGU – PASUQUIN** now invites bids for the **Concreting of Brgy. #04 Poblacion farm To Market Road** located at **Barangay #04 Poblacion, Pasuquin, Ilocos Norte**. Completion of the Works is required **five (5) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **LGU – PASUQUIN** and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **March 16 – April 05, 2023** from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 500.00.*
6. The **LGU - PASUQUIN** will hold a Pre-Bid Conference¹ on **March 24, 2023 at 1:00 PM** at **BAC Office, 2nd Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte** which shall be open to prospective bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (Php1,000,000) where the Procuring Entity may not hold a pre-bid conference.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **April 05, 2023 at 1:30 PM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **April 05, 2023 2:00 PM** at **BAC Office, 2nd Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
