

Invitation to Bid for

CONSTRUCTION OF PANGIL HANGING BRIDGE (Lacar Section)

- 1. The *LGU PASUQUIN* through the *RA 8240 CY 2020* intends to apply the sum of *Php 999,905.04* being the Approved Budget for the Contract (ABC) to payments under the contract for *MGPIN 2023 -08 156 Construction of Hanging Bridge (Lacar Section)* located at *Brgy. #16 Pangil, Pasuquin, Ilocos Norte*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *LGU PASUQUIN* now invites bids for the *Construction of Hanging Bridge* (*Lacar Section*) located at *Brgy. #16 Pangil, Pasuquin, Ilocos Norte*. Completion of the Works is required *thirty-two* (32) *calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *LGU PASUQUIN* and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *August* 29 September 18, 2023 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 1,000.00.
- 6. The *LGU PASUQUIN* will hold a Pre-Bid Conference¹ on *September 06, 2023 at 1:00 PM* at *3rd Floor, Municipal Hall, Pasuquin, Ilocos Norte* which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before *September 19, 2023 at 1:30 PM*. Late bids shall not be accepted.

May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

- All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- Bid opening shall be on September 18, 2023 2:00 PM at 3rd Floor, Municipal Hall, Pasuquin, Ilocos Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

- 11. The LGU PASUQUIN reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
