




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:



WHEREAS, **one (1) bid** was submitted on **February 07, 2024** and lone bidder passed the preliminary examination of bids.






NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:



- b) To recommend for approval by the Municipal Mayor of Pasuquin, Ilocos Norte the foregoing findings;






