CONCRETING OF DILANIS FARM TO MARKET ROAD (Sitio Kadalman Section)

- The LGU PASUQUIN through the 20% Development Fund CY 2025 intends to apply the sum of Php 1,499,846.39 being the Approved Budget for the Contract (ABC) to payments under the contract for MGPIN 2025 -05 070 Concreting of Dilanis Farm to Market Road (Sitio Kadalman Section) located at Barangay # 22 Dilanis, Pasuquin, Ilocos Norte. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU PASUQUIN now invites bids for Concreting of Dilanis Farm to Market Road (Sitio Kadalman Section) located at Barangay # 22 Dilanis, Pasuquin, Ilocos Norte. Completion of the Works is required nine (09) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *LGU PASUQUIN* and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *May* 20 to June 10, 2025 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 1000.00.
- 6. The *LGU PASUQUIN* will hold a Pre-Bid Conference¹ on *May 29, 2025 at 1:00 PM* at *3rd Floor, Municipal Hall, Pasuquin, Ilocos Norte* which shall be open to prospective bidders.

- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9. Bid opening shall be on *June 10, 2025* at 2:00 P.M. at the given address below 3rd Floor, Municipal Hall, Pasuquin, Ilocos Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
