


Invitation to Bid for

The LGU PASUQUIN through the REPAIR AND IMPROVEMENT OF PUBLIC BUILDINGS intends to apply the sum of Php 137,156.25 being the Approved Budget for the Contract (ABC) to payments under the contract for MGPIN-2025-06-059 - REPAIR AND IMPROVEMENT OF PUBLIC MARKET located at BARANGAY #02 POBLACION, PASUQUIN, ILOCOS NORTE. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU PASUQUIN now invites bids for MGPIN-2025-06-059 REPAIR AND IMPROVEMENT OF PUBLIC MARKET located at BARANGAY #02 POBLACION, PASUQUIN, ILOCOS NORTE. Completion of the Works is required seven (7) working days upon received the notice to proceed with a contract duration for a period of seven (7) working days. Bidders should have completed a contract similar to the Project. description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the New Government Procurement Act and its Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 12009.
- 4. Interested bidders may obtain further information from LGU PASUQUIN and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on, June 23 - July 1, 2025 from given address and website/s below and upon payment of the applicable fee for the Biddina Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 500.00.
- 6. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before July 1, 2025 at 2:00 PM. Late bids shall not be accepted.
- 7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 8. Bid opening shall be on July 1, 2025, 2:00 PM at 3rd Floor, Municipal Hall, Pasuquin, Ilocos Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
