## Invitation to Bid for

## IMPROVEMENT OF SCIENCE BUILDING

- The LGU PASUQUIN, through the Municipal School Board Fund CY 2024 and CY 2025 intends to apply the sum of Php 795,387.99 being the Approved Budget for the Contract (ABC) to payments under the contract for MGPIN 2025-09-189 – Improvement of Science Building. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The LGU PASUQUIN now invites bids for MGPIN 2025-09-189 Improvement of Science Building located at Davila National High School, Brgy. #05 Davila, Pasuquin, Ilocos Norte. Completion of the Works is required twenty-seven (27) calendar days Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
- 3) Bidding will be conducted through competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the IRR, otherwise known as the "New Government Procurement Act (NGPA)".
  - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4) Interested bidders may obtain further information from *LGU PASUQUIN* and inspect the Bidding Documents at the address given below from *8:00 A.M. to 5:00 P.M.*
- 5) A complete set of Bidding Documents may be acquired by interested bidders on **September 30, 2025 to October 20, 2025** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 1,000.00.
  - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6) The LGU-PASUQUIN will hold a Pre-Bid Conference on October 08, 2025 at 8:30 A.M. located at 3<sup>rd</sup> Floor, Mayors Session Hall, Municipal Building, Pasuquin, llocos Norte which shall be open to prospective bidders.

- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below on or before *October 20*, 2025 at 8:30 A.M. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9) Bid opening shall be on *October 20, 2025 at 8:30 A.M* at 3<sup>rd</sup> Floor, Mayors Session Hall, Municipal Building, Pasuquin, Ilocos Norte. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 10) Municipality of Pasuquin with address Maharlika Highway, Barangay 01 Poblacion, llocos norte with contact number (077) 670-0189.
- 11) The *LGU-PASUQUIN* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without thereby incurring any liability to the affected bidder or bidders.
