INVITATION TO BID FOR

ACQUISITION OF SALT MAKING EQUIPMENT AND PACKAGING MATERIALS AS SUPPORT TO LIVELIHOOD TO TRADITIONAL SALT MAKERS OF PASUQUIN, ILOCOS NORTE

- 1) The LGU-Pasuquin, through the **Trust Fund** intends to apply the sum of **Php 1,699,992.00**, being the Approved Budget for the Contract (ABC) to payments under the contract for **MGPIN No. 2025-11-264 – ACQUISITION OF SALT MAKING EQUIPMENT AND PACKAGING MATERIALS AS SUPPORT TO LIVELIHOOD TO TRADITIONAL SALT MAKERS OF PASUQUIN, ILOCOS NORTE**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The LGU-Pasuquin now invites bids for *the above Procurement Project*. Delivery of the Goods required is **thirty (30) calendar days**. Bidders should have completed, at least *within Two (2) years* from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR of RA No. 12009.


Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4) Interested Bidders may obtain further information from LGU-Pasuquin and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M., from *Monday to Friday*.
- 5) A complete set of Bidding Documents may be acquired by interested Bidders on **November 24, 2025 to December 2, 2025** from the address given below *upon* payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 5,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.



- 7) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
- 8) Bid opening shall be on **December 2, 2025 at 8:30 A.M.** at the *Municipality of Pasuquin with address Maharlika Highway, Barangay 1 Poblacion, Pasuquin, Ilocos Norte*. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 9) The *LGU-Pasuquin* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70⁴ of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
