Invitation to Bid for

REHABILITATION & IMPROVEMENT OF PUBLIC PLAZA

- 1) The LGU – PASUQUIN, through the **General Fund 2025** intends to apply the sum of **Php 869,275.31** being the Approved Budget for the Contract (ABC) to payments under the contract for **MGPIN 2025-12- 811 – Rehabilitation & Improvement of public Plaza**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The LGU - PASUQUIN now invites bids for **MGPIN 2025-12- 811 – Rehabilitation & Improvement of Public Plaza** located at **Public Plaza, Brgy. #01 Poblacion, Pasuquin, Ilocos Norte**. Completion of the Works is required **twenty-five (25) calendar days** Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).

- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR, otherwise known as the "New Government Procurement Act (NGPA)".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4) Interested bidders may obtain further information from LGU – PASUQUIN and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.
- 5) A complete set of Bidding Documents may be acquired by interested bidders on **December 05, 2025 to December 15, 2025** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 1,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below on or before **December 15, 2025 at 8:30 A.M.** Late bids shall not be accepted.
- 7) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 8) Bid opening shall be on **December 15, 2025 at 8:30 A.M** at 3rd Floor, Mayors Session Hall, Municipal Building, Pasuquin, Ilocos Norte. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
