Invitation to Bid for

REHABILITATION OF DRAINAGE CANAL ALONG PASUQUIN – TADAO ROAD (National Road to Ex-Pres. Luna Section)

- 1) The *LGU – PASUQUIN*, through the **Supplemental 2025** intends to apply the sum of **Php 1,999,691.22** being the Approved Budget for the Contract (ABC) to payments under the contract for **MGPIN 2026-01-013 – Rehabilitation of Drainage Canal Along Pasuquin – Tadao Road (National Road to Ex-Pres Luna Section)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The *LGU - PASUQUIN* now invites bids for **MGPIN 2026-01-013 – Rehabilitation of Drainage Canal Along Pasuquin – Tadao Road (National Road to Ex-Pres Luna Section located at Brgy. #02 Poblacion, Pasuquin, Ilocos Norte**. Completion of the Works is required **twenty-six (26) calendar days** Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR, otherwise known as the “New Government Procurement Act (NGPA)”.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4) Interested bidders may obtain further information from *LGU – PASUQUIN* and inspect the Bidding Documents at the address given below from **8:00 A.M. to 5:00 P.M.**
- 5) A complete set of Bidding Documents may be acquired by interested bidders on **January 27, 2026 to February 18, 2026** from the address below {Insert if necessary: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 5,000.00**.

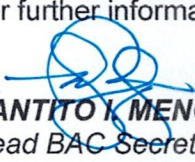
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6) The **LGU-PASUQUIN** will hold a Pre-Bid Conference on **February 06, 2026 at 8:30 A.M.** located at **3rd Floor, Mayors Session Hall, Municipal Building, Pasuquin, Ilocos Norte** which shall be open to prospective bidders.

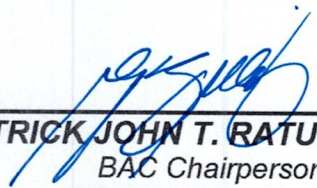

- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9) Bid opening shall be on **February 18, 2026 at 8:30 A.M** at **3rd Floor, Mayors Session Hall, Municipal Building, Pasuquin, Ilocos Norte**. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
