Invitation to Bid for

REHABILITATION OF SAN JUAN ROAD (Icas West Section)

- 1) The **LGU – PASUQUIN**, through the **Supplemental 2025** intends to apply the sum of **Php 499,806.56** being the Approved Budget for the Contract (ABC) to payments under the contract for **MPIN 2026-01-021 – Rehabilitation of San Juan Road (Icas West Section)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The **LGU - PASUQUIN** now invites bids for **MPIN 2026-01-021 – Rehabilitation of San Juan Road (Icas West Section)** located at **Brgy. #29 San Juan, Pasuquin, Ilocos Norte**. Completion of the Works is required **twelve (12) calendar days**. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR, otherwise known as the “New Government Procurement Act (NGPA)”.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4) Interested bidders may obtain further information from **LGU – PASUQUIN** and inspect the Bidding Documents at the address given below from **8:00 A.M. to 5:00 P.M.**
- 5) A complete set of Bidding Documents may be acquired by interested bidders on **January 27, 2026 to February 18, 2026** from the address below {*Insert if necessary: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 500.00.*}
- 6) The **LGU-PASUQUIN** will hold a Pre-Bid Conference on **February 06, 2026 at 8:30 A.M.** located at **3rd Floor, Mayors Session Hall, Municipal Building, Pasuquin, Ilocos Norte** which shall be open to prospective bidders.
- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below on or before **February 18, 2026 at 8:30 A.M.** Late bids shall not be accepted.


