## Invitation to Bid for

### **IMPROVEMENT OF HISTORICAL SITE (MUNICIPAL PARK) PHASE IV**


1. The **LGU - PASUQUIN** through the **SURPLUS CY 2020** intends to apply the sum of **Php 5,000,000.00** being the Approved Budget for the Contract (ABC) to payments under the contract for **MGPIN – 2021 – 02 – 022 Improvement of Historical mSite (Municipal Park) Phase IV, located at Barangay #01 Poblacion, Pasuquin, Ilocos Norte**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LGU - PASUQUIN** now invites bids for Improvement of **Improvement of Historical Site (Municipal Park) Phase IV, located at Brgy. #01 Poblacion, Pasuquin, Ilocos Norte**. Completion of the Works is required **one hundred (100) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **LGU – PASUQUIN** and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **February 10 – March 03 2021** from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 10,000.00*.
6. The **LGU - PASUQUIN** will hold a Pre-Bid Conference<sup>1</sup> on **February 19, 2021 at 1:00 PM** at **BAC Office, 2<sup>nd</sup> Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte** which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **March 03, 2021 at 1:30 PM**. Late bids shall not be accepted. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
9. Bid opening shall be on **March 03, 2021 2:00 PM** at *BAC Office, 2<sup>nd</sup> Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
