**INVITATION TO BID FOR**

***Purchase of Medical Supplies and Equipment***

1. The *LGU-Pasuquin* through the *General Fund CY 2022* intends to apply the sum of *Php1,498,950.00* being the ABC to payments under the contract for *MGPIN-2022-07-105- Purchase of Medical Supplies and Equipment* located at *Municipal Hall, Pasuquin, Ilocos Norte*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *LGU-Pasuquin* now invites bids for the above Procurement Project. Delivery of the Goods is required for *thirty (30) calendar days*. Bidders should have completed, within *one (1) year* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *LGU-Pasuquin* and inspect the Bidding Documents at the address given below during *8:00 AM to 5:00 PM*
5. A complete set of Bidding Documents may be acquired by interested Bidders on *July 15 – August 08, 2022* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of (Php)5,000.00*.
6. The *LGU - PASUQUIN* will hold a Pre-Bid Conference<sup>1</sup> on *July 27, 2022 at 1:00 PM* at *BAC Office, 2<sup>nd</sup> Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte* which shall be open to prospective bidders.


