## **Invitation to Bid for**

### ***REHABILITATION OF THE ACCESS ROAD WITHIN THE SANITARY LANDFILL***

1. The **LGU - PASUQUIN** through the **LGSF – Other Financial Assistance (FA)** intends to apply the sum of **Php 1,999,988.68** being the Approved Budget for the Contract (ABC) to payments under the contract for **MGPIN – 2023 –02 - 024 – Rehabilitation of the Local Access Road within the Sanitary Landfill** located at **Brgy. #22 Dilanis, Pasuquin, Ilocos Norte**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LGU – PASUQUIN** now invites bids for the **Rehabilitation of the Local Access Road within the Sanitary Landfill** located at **Brgy. #22 Dilanis, Pasuquin, Ilocos Norte**. Completion of the Works is required **ten (10) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **LGU – PASUQUIN** and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **February 21 – March 13, 2023** from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00*.
6. The **LGU - PASUQUIN** will hold a Pre-Bid Conference<sup>1</sup> on **March 01, 2023 at 1:00 PM** at **BAC Office, 2<sup>nd</sup> Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte** which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **March 13, 2023 at 1:30 PM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
9. Bid opening shall be on **March 13, 2023 2:00 PM** at *BAC Office, 2<sup>nd</sup> Floor, Municipal Sports Complex, Pasuquin, Ilocos Norte*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
