



**BAC RESOLUTION NO. BACRES-2025-02-003**

**RECOMMENDING AWARD OF CONTRACT FOR THE CUSTUME FOR THE TAN-OK DANCERS THROUGH "NEGOTIATED PROCUREMENT-SMALL VALUE PROCUREMENT (NP-SVP) UNDER SECTION 53.9 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) S REPUBLIC ACT (RA) 'ON 9184"**

**WHEREAS**, on **27 January 2025**, Municipal Mayor, Robert D. Aguinaldo, as Head of Procuring Entity (HOPE), approved the **MGPIN.2025.01.009-CUSTUME FOR THE TAN-OK DANCERS** located at **PASUQUIN, ILOCOS NORTE** with an Approved Budget for the Contract (ABC) of **Two Hundred Thousand Pesos Only (PhP 200,000.00)**, will be acquired pursuant to **Section 53.9 (Small Value Procurement)** of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

**WHEREAS**, the **Municipal Government of Pasuquin, Ilocos Norte** advertised the Request for Quotations (RFQ) for **MGPIN-2025-01-009-CUSTUME FOR THE TAN-OK DANCERS** located at **PASUQUIN, ILOCOS NORTE** at the Philgeps and three conspicuous places at the premises of the Municipal Building at Pasuquin, Ilocos Norte continuously for 7 calendar days;

**WHEREAS**, in response to the said advertisements, **two (2) suppliers** logged in the PhilGEPS and distributed **three (3)** Request for Quotations (RFQ) on bonified suppliers and set the deadline of submission of quotations including the eligibility requirements on **February 06, 2025**;

**WHEREAS**, **three (3)** price Quotations was submitted and opened on **February 06, 2025**, namely.

**NOW, THEREFORE,** We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby **RESOLVED:**




