

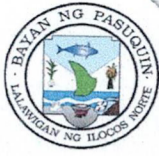


## Invitation to Bid for

### **PURCHASE OF FOAM MATTRESSES WITH COVERS FOR THE BEDDING OF THE DELEGATION DURING THE BILLETING FOR THE PALARONG PAMBANSA 2025**

1. The **LGU-Pasuquin** through the **SEF CY 2025** intends to apply the sum of **Php 499,994.00** being the ABC to payments under the contract for **MGPIN-2025-04-051 - PURCHASE OF FOAM MATTRESSES WITH COVERS FOR THE BEDDING OF THE DELEGATION DURING THE BILLETING FOR THE PALARONG PAMBANSA 2025** located at **PASUQUIN, ILOCOS NORTE**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LGU-Pasuquin** now invites bids for the above Procurement Project. Delivery of the Goods is required for **immediately upon received the notice to proceed with a contract duration for a period of seven (7) working days**. Bidders should have completed, within **one (1) year** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **LGU-Pasuquin** and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **April 23 – May 02, 2025** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of (Php 500.00).
6. Bids must be duly received by the BAC Secretariat at the office address below on or before **May 02, 2025 at 2:00 P.M.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
7. Bid opening shall be on **May 02, 2025 at 2:00 P.M.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
